A. No student may participate in any of these activities without first having signed and dated the Release.

- B. Students must be given the opportunity to read the Release and ask questions prior to signing. All risks inherent in the activity - particularly those which may not be readily evident - must be discussed with students before they are asked to sign.
- C. The Release must be filled out completely, with no spaces left blank.
- D. If a student is not yet 18 years old, **both** the student and his or her parent or guardian **must** sign.
- E. Youth directors are responsible to distribute, explain, and collect the Release.
- F. The signed original Release is to be retained by Salt 'n Light Youth Ministry the program director for **two years** after the completion of the activity for which the Release is signed.
