I AGREE TO USE REASONABLE CARE WHILE PARTICIPATING IN THIS ACTIVITY. In consideration of being permitted to participate in the activity, I AGREE, on behalf of my family, heirs and personal representatives, TO ASSUME ALL THE RISKS and responsibilities involved in my participation in the activity. I RELEASE and agree to indemnify and hold harmless Salt 'n Light Youth Ministry, its trustees, employees, agents and volunteer activity leaders, from and against any present or future liability, claims or actions that may arise from injury or harm to me, from my death, from damage to my property, or for which I may be liable to another person, as a result of my participation in the activity EXCEPT FOR injury, death or damage resulting from the gross negligence or willful misconduct of Salt 'n Light Youth Ministry, Inc.

I understand that Salt 'n Light Youth Ministry will not have medical personnel available at the site of the activity. I have no health-related conditions which preclude or restrict my participation in the activity. I agree that Salt 'n Light Youth Ministry is not responsible for my medical or medication needs and assume all risk and responsibility for such needs. I grant Salt 'n Light Youth Ministry permission to authorize emergency medical treatment for me, if necessary, and agree to reimburse Salt 'n Light Youth Ministry for any costs. Further, I agree that Salt 'n Light Youth Ministry assumes no responsibility for any injury or damage which might arise out of or in connection with authorized emergency medical treatment. I agree that this Release shall be interpreted in accordance with the laws of the Commonwealth of Pennsylvania. The invalidity of any part of it shall not affect the validity of the remaining parts. I understand that I am giving up my rights to sue Salt 'n Light Youth Ministry for injury, loss, or death which I may suffer as a result of participating in the activity.
