I understand that **Salt 'n Light and Camp Hill UMC** do not require me to participate in this activity, but I want to do so and choose to participate voluntarily, despite the possible dangers and risks.

**I understand that the activity may involve significant physical exertion and that it is possible for me to suffer a serious injury during practice, conditioning, travel, or participation in the activity. I understand that such an injury could result in death or other serious physical and/or psychological harm and damage to me or my property. I have been warned of the significant non-obvious risks associated with this activity, have full knowledge of these risks, and realize that I am responsible for my own safety and wellbeing while participating in this activity.**

I AGREE TO USE REASONABLE CARE WHILE PARTICIPATING IN THIS ACTIVITY. In consideration of being permitted to participate in the activity, I AGREE, on behalf of my family, heirs and personal representatives, TO ASSUME ALL THE RISKS and responsibilities involved in my participation in the activity. I RELEASE and agree to indemnify and hold harmless Salt 'n Light Youth Ministry, its trustees, employees, agents and volunteer activity leaders, from and against any present or future liability, claims or actions that may arise from injury or harm to me, from my death, from damage to my property, or for which I may be liable to another person, as a result of my participation in the activity EXCEPT FOR injury, death or damage resulting from the gross negligence or willful misconduct of Salt 'n Light Youth Ministry, Inc, and Camp Hill UMC.

I understand that Salt 'n Light Youth Ministry and Camp Hill UMC will not have medical personnel available at the site of the activity. I have

no health-related conditions which preclude or restrict my participation in the activity. I agree that Salt 'n Light Youth Ministry and Camp Hill UMC are not responsible for my medical or medication needs and assume all risk and responsibility for such needs. I grant Salt 'n Light Youth Ministry and/or Camp Hill UMC permission to authorize emergency medical treatment for me, if necessary, and agree to reimburse Salt 'n Light Youth Ministry and Camp Hill UMC for any costs. Further, I agree that Salt 'n Light Youth Ministry and Camp Hill UMC assumes no responsibility for any injury or damage which might arise out of or in connection with authorized emergency medical treatment. I agree that this Release shall be interpreted in accordance with the laws of the Commonwealth of Pennsylvania. The invalidity of any part of it shall not affect the validity of the remaining parts. **A. No student may participate in any of these activities without first having signed and dated the release.**

**B. Students must be given the opportunity to read the Release and ask questions prior to signing. All risks inherent in the activity - particularly those which may not be readily evident - must be discussed with students before they are asked to sign.**

**C. The Release must be filled out completely, with no spaces left blank.**

**D. If a student is not yet 18 years old, both the student and his or her parent or guardian must sign.**

**E. Youth directors are responsible to distribute, explain, and collect the Release.**

**F. The signed original Release is to be retained by Salt 'n Light Youth Ministry the program director for two years after the completion of the activity for which the Release is signed.**
